Approval of Minutes – The minutes from May 22, 2014 were presented. A motion to accept was made by Carol Slaughter , seconded by Aileen Hunt, and unanimously approved.

Speakers

Our District 2 rep on the **Birmingham Board of Education, Lyord Watson**, explained the issues involved in the Special Election and board request for a tax increase for schools. The new board is making progress, with graduation rates up from 56% to 65%, and drop-out rates down from 12% to 4%. Birmingham City schools are past the accreditation probation, and expect to be off probation all together in September.

The requested three mils increase is estimated to raise an extra \$7.8 million.
